Budget process 2010-11: Cautious optimism for maintaining current school programs

Minnville School District is in the middle of budgeting for the 2010-11 school year. State law defines the process local governments use in setting budgets. School boards must meet a June deadline for adopting a budget for the coming year. In most legislative years, the K-12 legislative budget is not known by the school budget deadline.

For this reason, schools are often faced with uncertainty about the funding they will have from the state as they set their budgets.

Reductions in 2009-10

Last year, school districts based budgets on potential funding scenarios as recommended by the Governor — they were forced to take their best guess about what the funding levels would be.

McMinnville Schools built a budget based on a \$5.8 billion state funding level – neither the top nor bottom of the recommended range. This level was less than the cost of rolling forward current programs and services in the District. To balance the budget at this funding level, the District identified \$5.5 million in implemented reductions.

Reductions were made in programs and staff, onetime funds were tapped, and staff concessions included a five-day pay reduction for all staff and cost-of-living and step freezes for classified, administrative and confidential staff.

Restoring budget cuts in 2010-11

This year, the District anticipates a higher funding level that would allow restoration of some educational programs and reinstatement of work calendars for employee groups next year.

In the coming months, the Budget Committee will review current services, anticipated funding and future projections. They will make a recommendation to the School Board in May.



making progress meeting state benchmarks and meeting state and federal requirements.


School CIPs are used to identify school goals each year and develop action plans for reaching them.

Each school reviews data from the previous year, including assessment results, attendance rates, etc., to identify successes and challenges and define specific strategies to meet student needs. The plans also provide information about school climate and parent involvement.

Vision 2020 input process helps set education priorities



The Vision 2020 strategic planning process started last year and included dozens of forums and opportunities for input from a wide range of community members, parents and staff.

This process defined the educational priorities of our community and

will set the course for future District goals.

Based on this input, the following are the top three priorities and the District response for addressing them:

District priority: Post-secondary education and employment opportunities

District response:

- College Credit Now, Advanced Placement, pathway programs, and business partnerships
- Staff position to monitor and assist student enrollment in post-secondary program

District priority: Safe schools

District response:

- Design schools to incorporate safety features related to facility access and supervision.
- Monitor and enhance the work of school safety and

- Effective Behavior and Instructional Support (EBIS) committees.
- Continue to decrease referrals for inappropriate student behaviors.
- Maintain and enhance focus on positive school climate.
- Evaluate effectiveness of current systems in place, including video surveillance program, crime prevention though environmental design, threat assessment program, safety drills, etc.

District priority: Well-rounded curriculum

District response:

- Maintain music, physical education and elective programs for students.
- Expand music and elective offerings in conjunction with core content intervention programs for students who struggle to meet benchmark as resources become available.
- Continue to build coursework rigor for all students.

The District is also responding to the following other areas that were identified during the input gathering process:

- Critical skills/educational excellence
- Community relations/student behavior/family involvement
- Technology
